

## **Win Brent Chapman's Tournament Rig**

### **2017 OFFICIAL RULES**

This contest is presented by Kansas BASS Nation ("KBN") in conjunction with Brent Chapman. Complete entry information is available on <http://www.ksbassnation.com/>

***PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASE OF MULTIPLE TICKETS WILL INCREASE YOUR CHANCE OF WINNING.***

#### **1. CONTEST DATES**

a. The Win Brent Chapman's Tournament rig ("Contest") presented by KBN will begin on or about January 1, 2017 at 8:00 a.m. CT and ends on October 31, 2017 at 11:59 p.m. CT, or when all tickets are sold.

#### **2. ELIGIBILITY RESTRICTIONS**

a. The Contest is open to all legal residents of the United States and the District of Columbia (except NY and FL) who are 18 years of age or older at the time of entry. This Contest is subject to all applicable federal, state, and local laws and regulations. Void outside the United States, in NY and FL, as applicable, and where prohibited.

b. Persons of legal age may purchase as many tickets for the contest as they wish. One prize will be awarded at contest end. Failure to comply with rules will result in forfeit of the prize.

c. Selected winner will be required to provide a valid state issued ID to verify age and identity, and to complete a W-9 (if requested) when claiming the prize in this Contest.

d. Entrants are required to provide truthful information and the KBN will reject and delete any entry that it discovers to be false or fraudulent. The KBN will disqualify any entry from individuals who do not meet the eligibility requirements, and will also delete any entry as required by law.

#### **3. ENTRY**

a. To participate in the Contest, you may enter via the following method(s):

<http://www.ksbassnation.com/> Follow the links and instructions on <http://www.ksbassnation.com/> to enter participants will be required to submit your information, including: first name and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online purchase form. Internet entries will be deemed made by the authorized account holder of the payment method submitted at the time of entry. Multiple entrants are permitted to share the same email address. Entries submitted will be acknowledged by printable receipt with entry number. Use of any device to automate entry is prohibited. The contest/sweepstakes administrator's computer is the official time keeping device for the Contest. For purpose of this Contest, a "Day" shall begin at 12:00:00 a.m. CT and shall end at 11:59:59 p.m. CT.

#### **4. PRIZE**

- a. Contest prize will be awarded to the 1 entrant whose ticket is selected. The Grand Prize for the contest is Brent Chapman's 2017 Tournament Boat.
- b. The Contest is a chance drawing. The odds of winning depend upon the number of tickets sold with a maximum of 1,000, and the number of tickets the purchased by the individual.
- c. There is no substitution, transfer, or cash equivalent for prizes, except that the KBN may, at its sole discretion and to the extent permitted by law, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### **5. WINNERS SELECTION AND NOTIFICATION**

- a. Decisions of KBN management with respect to the Contest are final.
- b. Selected winner will be determined no later than November 30, 2017.
- c. Winner will be selected by random draw.
- d. Winner does not need to be present to be selected to win.
- e. Selected winner will be notified by email / phone no later than November 30, 2017. Winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of notification attempt or winner will be disqualified and the prize will be forfeited and an alternate winner may be chosen by by random selection from qualified entries. If a potential winner cannot be contacted, fails to complete, sign and return the required affidavit of eligibility and liability/publicity release within the required time period, the potential winner will be disqualified and will forfeit the prize.
- f. Unless otherwise specified in the prize notification, the prize may be picked up in person at the contest drawing site. The winner will forfeit any prize not claimed in-person within thirty (30) days of winning.

Failure to submit a complete W-9 or equivalent will result in disqualification and forfeiture of the prize.
- b. The KBN further reserves the right, at its sole discretion, to modify, cancel, terminate or suspend the Contest, or any part of it, if it is not capable of completion as planned or if any fraud, technical failures or any factor beyond the KBN's control, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort, corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest as determined by the KBN in its sole discretion. Any attempt by an entrant or any person to deliberately damage any KBN web channel or to undermine the legitimate operation of this Contest may be a violation of criminal and civil laws. Should such an attempt be made, the KBN reserves the right to seek full prosecution and/or damages from any such individual to the fullest extent permitted by law. The KBN's failure to enforce any term of these Official Rules shall not constitute a waiver of this provision. If due to circumstances beyond the control of the KBN, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the KBN reserves the right, but not the obligation, to modify, terminate, suspend or cancel the Contest and shall not be required to award a substitute prize.

e. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Contest, or in the announcement of a prize; (ii) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, malfunctions, disconnections, other technological failures, telephone service outages, delays, dropped calls, or busy signals, or any other difficulties that may prevent an individual from sending or receiving a text message; or (iii) lost, stolen, mangled, misdirected, postage due, illegible, incomplete, incorrect, or late entries.
